Abstract : This book describes the pattern of land tenure and resulting social structure in the Ceylonese village of Madagama. It analyses the system in detail, and traces the evolution of every land holding and the correlated kinship pattern from the

the estate in 1790. The traditional cultivation and economy has been modified by a land shortage, causing the multiple division of shares, and by British rule which introduced the introduction of Roman-Dutch law and the development of a cash economy. The practice of mortgaging and share speculation then became the basis of a power struggle away from feudal norms of land ownership, and leading to radical reorganization of the traditional hamlet. This study complements Dr E. R. Leach's investigation of kinship and kinship in Pul Eliya, and has implications for many other agrarian societies. The detailed analyses of land holdings, with the many kinship charts, form an interesting example of anthropological technique.
