Reconciling a Troubled Union

In the United States, a popular metaphor for the relationship between law and psychiatry has been marriage. The legal-psychiatric union is rarely depicted as a happy one; instead we have a portrait of a relationship marked by almost continuous conflict. An emphasis on hostility is understandable, given the distinctive and often contradictory intellectual aims and professional methods, obligations and goals of law and psychiatry. Yet, this “marriage on the rocks” image has obscured an important aspect of the legal-psychiatric interaction. What is missing is a satisfactory appreciation of the organized efforts made to reconcile these volatile partners.

Such reconciliation campaigns have occurred regularly in the United States since the middle of the 19th century, and have involved a prestigious array of institutional sponsors, including the New York Medico-legal Society, the American Institute of Criminal Law and Criminology, the National Research Council, the United States Congress, Harvard University, Yale University, the American Bar Association, the American Medical Association, and the American Psychiatric Association. Each of these institutions approached the problem of reconciliation from its own distinctive perspective. Educational institutions such as Harvard and Yale sponsored interdisciplinary training programs and research projects, while professional associations like the American Psychiatric Association favored projects that were designed to improve relations between practitioners from differing disciplines and to foster legislative reform. Reform legislation was also an important part of the investigations made by the National Research Council and Congressional committees. Although the inter-professional endeavors sponsored by these various organizations differed markedly in structure and function, they have shared a dedication to a common principle—greater legal-psychiatric cooperation (Burns, 1980, pp. 281–82; Tighe, 1983a, 1983b, pp. 181–226, 310–81, 436–500).
