Abstract

The first author to suggest an origin and spread of Dupuytren's disease was Early who wrote in 1962, "if one postulates the condition as having arisen in one particular racial group (the Nordic for example) then the variable distribution in other parts of the world might be explained on the basis of migration from that group."
