Chapters 1 through 3 provide the foundation for a philosophical understanding of moral reasoning, developing a consistent value system based on honesty, responsibility, and beneficence. Chapters 4 through 11 focus on the application of sport in which individuals are challenged to use moral reasoning to decide how to respond to ethical dilemmas, examining issues such as intimidation and game-fixing.
