



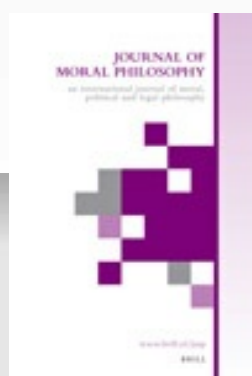

Alasdair MacIntyre has recently had published two books of selected essays, a study of the phenomenologist Edith Stein, *After Virtue*, and an extensive collection of his early Marxist writings. These are reviewed, along with two recently published works. The recent reinterpretation and revival of interest in that work receives much support from most of these publications. The recent reinterpretation is the concept of practices, which MacIntyre first elaborated in *After Virtue*. His recent work indicates a further development in the direction of a politically radical moral realism.
