Abstract

Medical error has become a topic of much concern in recent years. Doctors'™ responses to their own or others'™ medical errors are important because openness or secrecy has an impact on efforts to reduce iatrogenic injury, on malpractice litigation, and on patient and doctor satisfaction with care.
